Library of Ibn Sina Academy - The First Indian Library in the Directory of History of Medicine Collections of US National Library of Medicine (NLM)

Crystal Smith (crystals@mail.nih.gov), Reference Librarian in the History of Medicine Division of the National Library of Medicine (National Institutes of Health, US Department of Health and Human Services) has informed that the library of the Ibn Sina Academy has been listed in the Directory of History of Medicine Collections of US National Library of Medicine. It is the first collection representing from India. The Directory is published annually and is also available online: www.nlm.nih.gov/hmd/directory/directoryhome.html.

Presently, 147 museums, libraries and archives that have holdings in the history of the health sciences are included in the Directory. According to Crystal Smith, the goal is to build an informal network of historical collections that would be useful to scholars and researchers worldwide. The next 2006 printed edition is expected to be published by March 2006.

Releasing Ceremony of an old Book: Muraggah-e College

A function to release the second edition of 'Muraggah-e College' was held at the Library Hall of Ibn Sina Academy, Tijara House, Dodhpur, Aligarh, on November 14, 2005. Prof. Mukhtar Uddin Ahmad, a renowned Arabic scholar & critic, released the book, while Nawab Rahmatullah Khan Sherwani Saheb over the function. The book, which was earlier published in 1916 authored by an old boy of MAO College, Mohammad Badruddin Siddiqui of Bijnore, is revised and edited by his son, Mr. M. Qasim Siddiqui, former principal of Senior (Plus-2) School of Aligarh Muslim University. Mohammad Badruddin Siddiqui, who studied in the MAO College from 1904 to 1913 (9 years). was the elder brother of Maulana Hifzur Rahman. a prominent scholar and freedom fighter. Abdur Kahman Bijnori who is famous for his works on Ghalib and Hafiz Mohammad Ibrahim (former Central Minister and Governor of Punjab) also belonged to his family.

Kress Visiting Fellowship 2006-2007

The Samuel H. Kress Foundation, with the support of the American Friends of the Warburg Institute, will offer a Kress Visiting Fellowship at the Warburg Institute, from October 2006 through June 2007, with a salary of \$45,000, plus a travel allowance of \$2,500. The Fellowship is open to American scholars. Applicants should have at least five years of teaching experience. The Fellowship is tenable for one year. Please note that applicants must be U.S. citizens or U.S. permanent residents.

The Fellow will be required to undertake research on any aspect of the history of European art and its context consistent with the resources of the library, photographic collection or archive of the Warburg Institute. In addition the Fellow will be expected to offer a course for the Institute's MA in Cultural and Intellectual History 1300 - 1650, to give informal advice to MA and PhD students and to participate in the scholarly life of the Institute. The Fellow is required to be based at the Institute during university terms, which fall between 1 October and 30 June.

Bakken Fellowships and Grants

Each year, the Bakken Library and Museum of Electricity in Life (Minneapolis) offers two forms of assistance to facilitate research in its collection of books, journals, manuscripts, and instruments: (a) Visiting Research Fellowships and Research Travel Grants.

Visiting Research Fellowships up to a maximum of \$1,500 are to help defray the expenses of travel, subsistence, and other direct costs of conducting research at the Bakken Library. The minimum period of residence is two weeks. Preference is given to researchers who are interested in collaborating with the Bakken Library on exhibits or other programs. The deadline for visiting research applications is 20th February 2006.

(b) Travel Grants up to a maximum of \$500 (domestic) and \$750 (foreign) are to help defray the expenses of ravel, subsistence and other direct costs of conducting research at the Bakken Library. The minimum period of residence is one week. Application may be made at any time during the calendar year; there are no deadlines.

The Bakken collections include approximately 11,000 books, journals, and manuscripts, and close to 2,000 instruments and machines. The subject of the collections is the history of electricity and magnetism with a focus on their roles in the life sciences and medicine.

Wellcome Studentships in History of Medicine The Department of History and Philosophy of Science at the University of Cambridge invites applications from candidates with interests in any areas of history of medicine who would like to be nominated for the Wellcome Trust's annual master's award and doctoral studentship competitions. The Department also invites applications for two doctoral studentships funded by a Wellcome enhancement award in history of medicine. Outstanding candidates whose research would fall in the field From Generation to Reproduction', i.e., who would investigate some aspect of how, since 1500, our world of reproductive practice and controversy was created. Special interest attaches to the constitution of 'reproduction' as a new object of medical intervention and scientific research, and the increasing modern detachment of sex and reproduction.

Post-doctoral fellowship at the Université catholique de Louvain (Belgium) in the field of medieval encyclopaedism

The project

"Encyclopédies comme images du monde et comme vecteurs d'échanges intellectuels dans l'Islam et l'Occident au Moyen Age" is a research project founded in 2003 by Baudouin Van den Abeele and Godefroid de Caliatay (Université catholique de Louvain). Through the comparative study of medieval encyclopaedias in Islam and the Latin West, the project aims at bringing out new perspectives on how the two cultures interacted and influenced one another in this crucial period of their history. The approach is interdisciplinary, as it combines philology (research on manuscript traditions, textual editions and translations) with the outcome of historical investigation about the transmission of sciences and ideas.

The grant is a 24-month post-doctoral fellowship to be held at the Université catholique de Louvain. It amounts to about 1.800 curos per month (as minimum net salary). Its tenure is normally due to start in January 2006. As a full-time employment, it implies residency in Belgium during the whole period and is not accessible to people having already worked in this country under post-doc status during the last two years.

Field of research concerned: It has been agreed that the 24-month fellowship would be designed to conduct a study of the following topic: "Direct and indirect influences of the lkhwan al-Şafā' (Brethren of Pacity, 10th c, AD) in the West"

This study, which is meant to be made in collaboration with G. de Callataÿ, should result in the joint publication of a comprehensive monograph on the subject.

Requirements: Candidates should be less than 38 years. They are expected:

- to have written a PhD thesis in the field of intellectual history in Islam and its relationship with the West.
- to be thoroughly familiar with both Classical Arabic and Latin (and eventually other languages like Hebrew and Old French), and
- to have a good command of French and English.

OBITUARY

We publish below an Obituary of Prof. David Pingree (of Brown University, USA). To us (Indians) Pingree is known particularly as a critical historian of Indian astronomy par excellence. Some of his monumental works are:

Pingree, David (1970–1994), Census of the Exact Sciences in Sanskrit, Series A, Memoirs of the American Philosophical Society, Philadelphia. Till 1994, five volumes have been published. In this bio-bibliography, Pingree lists the extant manuscripts of a work and his author, information about its commentaries, editions and also secondary literature, if any. This is presently the most comprehensive source of information on the scientific works in Sanskrit.

in Liège (Belgium) at the International Congress of History of Science in 1993. He was an extremely nice human being, loved and helped scholars from every part of the world. On our personal request, he contributed readily an article to Studies in History of Medicine and Science (Ed. S.M.R. Ansari), Vol. 12 (1993), pp. 69-79, lt is a matter of great satisfaction to us that we have also contributed to his Felicitation Volume: Studies in the History of the Exact Sciences in Honour of David Pingree, Eds. Charles Burnett, Jan P. Hogendijk, Kim Plofker and Michio Yano (Series: Islamic Philosophy, Theology and Science, Text and Studies, Ed. H. Daibar and D. Pingree, Vol. LIV) Brill, Leiden, 2004, 890 pages. The topic of our article is: "Sanskrit Scientific Texts in Indo-Persian Sources, with Special Emphasis on Siddhanta and Karanas", a humble tribute to his great work on History of Indian Astronomy.

David Pingree was a prolific scholar. In the Felicitation Volume, his bibliography runs in 19 pages. He has published 32 books and monographs, more than 250 papers in learned journals and about 100 entries in various encyclopaedias.

His passing away is indeed a great loss to the community of historians of science. May his soul rest in peace.

DAVID E, PINGREE, Ph.D., 72, of Halsey St., a University Professor and Chairman of the Department of the History of Mathematics at Brown University, died on Friday, 16.11.05, in the Miriam Hospital. He was the beloved husband of Isabelle (Sanchirico) Pingree

Born in New Haven, CT, son of the late Daniel and Elizabeth (Maconi) Pingree, he has lived in Providence (Rhodes Island, USA) since 1971. Professor Pingree was a graduate of Phillips Academy, Andover and Harvard University, where he received both his undergraduate and graduate degrees. Following college, he became

keenly interested in the transmission of scientific ideas from one culture to another. In 1958, he went to India to study Sanskrit. Upon return in 1960, he became a member of the Society of Fellows at Harvard where he learned Arabic and started to accumulate lists of relevant manuscripts on the exact sciences in Sanskrit.

Professor Pingree had been a member of the faculty of the University of Chicago and joined the faculty at Brown University in 1971, becoming Chairman of the Department in 1986. Throughout his distinguished career, he travelled in India and throughout the world collecting and cataloguing astronomical and astrological manuscripts. He was widely published, including many Sanskrit astronomical tables, catalogues of thousands of manuscripts, a Census on the Exact Sciences in Sanskrit, and the Latin translation of the Arabic Picatrix among others. Some 43 books and monographs and 240 articles have appeared under his name. He was the recipient of countless scholarly awards including a Guggenheim Fellowship, a McArthur Fellowship, and in 1992 he received an Honorary Degree of Doctor of Humane Letters from the University of Chicago. He was elected a Fellow of the American Academy of Arts and Sciences, was a member of both the American Philosophical Society and the Institute for Advanced Study and was the cofounder of the Association of Members of the Institute for Advanced Study. He established the American Committee for South Manuscripts in 1994 with the goal of cataloguing all the Arabic, Persian and Indian manuscripts in North America and elsewhere.

Besides his wife, he leaves a daughter, Amanda Pingree of Rome, Italy, a brother John Pingree of North Palm Beach, FL, a brother Peter Pingree of North Reading, MA, and a sister Sarah Dousa of Andover, MA.

ligarh Magazines extant in the Library of Ibn Sina Academy

Prof. Hakim Syed Zillur Rahman is a man of many interests. On one hand, he is an expert in Unani Medicine, a historian and a scholar of repute: on the other hand he is a philanthropist and a great hibliophile. He established his personal library-cum-museum in early 1960s. After the establishment of Ibn Sina Academy of Medieval Medicine and Sciences (IAMMS) in 2000 AD, this Library and Museum have become a part of IAMMS, which is a Registered Trust.

The Library of IAMMS houses at present one of the most precious and valuable collection of over 400 manuscripts; 15,000 printed books in many languages like Arabic, Persian, Urdu, Sanskrit, Hindi, even Russian and evidently English; 10,000 periodicals; a few hundreds special number of magazines and many specimens of oriental calligraphy. Most of the manuscripts are very rare and some are unique. The extant copies of the Holy Quran are extremely beautiful specimens of the art of calligraphy. A few illustrated copies of the Holy Quran, having beautiful frontispieces embellished borders, are so alluring and eyecatching that any one who looks at them is dazzled and stands spellbound in wonder. Many scholars and generous contributors have helped in furnishing the Ibn Sinå Academy Library with books and other rare novelties.

Following sections in the Library are noteworthy: History of Medicine and Sciences, Unani Medicine, Ilmul Advia/ Pharmacology, Ghalib Studies, Sir Mohammad Iqbal Studies, Biographies, Bhopal Studies, Aligarh and Sir Syed Ahmad Khan.

Sections on Aligarh and Sir Syed possess a good collection of books on the History of MAO College, Aligarh Muslim University and its founder Sir Syed Ahmad Khan, and also on his colleagues. The Library contains many books authored by the old boys and staff of both MAO College and the Muslim University. Books/Material on diverse themes are also extant in the Library, for instance, University Culture and Traditions, Biographies / Autobiographies of Distinguished Old Boys,

university colleges and departmental publications. The periodical section has also a long list of journals/periodicals, such as Fikro Nazar, Takzibul Akhlaq. Residential and NRSC Hall Magazines, University Gazettes, Muslim Educational Conference Gazettes, Annual Reports of the University, Souvenirs of AMU Old Boys' Associations, Aligarian of Students' Union, Proceedings of Seminars and Conferences, etc.

Aligarh Magazine in both Urdu and Eaglish language is one of the important periodical of the University. It started publishing from the days of the MAO College (as Aligarh Monthly since 1903), and hence it is difficult to find all issues of Aligarh Monthly Magazines at one place. An attempt had been made to collect these magazines in the Library of Ibn Sina Academy. Some of the issues (in Urdu and English), which are extant in the Library are listed below.
