EVENTS AT IBN SINA ACADEMY (January — March 2013)

Guest Lecture Series 31

Professor Gordon Campbell, an expert of Renaissance studies, Leicester University, UK delivered a lecture on 'Education in the Muslim World' here at Ibn Sina Academy.

While welcoming the guests, Prof. Syed Zillur Rahman, President, Ibn Sina Academy said that the Academy has been instrumental in preserving the Indian culture, heritage and educational values. Today's lecture is a series of guest lectures that has been organizing for the last 12 years on several topics of relevance.

Prof Abdur Rahim Kidwai, the executive member of Ibn Sina Academy, while introducing the speaker Prof. Campbell, said Prof Campbell is a renowned name in the Islamic world. He served as Chairman and President of the English Association and as Chairman of the Society for Renaissance Studies. Professor Campbell is a Fellow of several learned societies including the Society of Antiquaries, Royal Historical Society, Royal Geographical Society, Royal Asiatic Society, etc. He travelled widely including many Muslim dominating countries. He has been closely associated with the delivery of education in the Muslim world as the founding chair of the Consortium of British Universities in Iraq and Saudi Arabia. He has published extensively on English Literature, Cultural Architecture, Biblical History, Arts. Studies, Classical Antiquity, Garden History, Legal History, Historical Theology and the Islamic World. Presently he is writing a book engaged in entitled "Contemporary Islam" to be published by the Oxford University Press. He has a keen interest in Islam and the Muslim world.

Professor Gordon Campbell in his guest lecture, said, education among masses of Muslims is very crucial for the progress of any country. No country can boast of development if its sizeable population remains illiterate and poor. He gave the example of Turkey, Iran and other countries. He praised that the large numbers of population of these countries education, engaged in higher reconstruction of community, and society. In an earlier era, political or religious leaders would prescribe, and others were supposed to follow. Today, the major impetus for change in religious and political values comes from below. In France, this has meant an identity shift from being Muslim in France to being French Muslim. In Turkey, it means that an increasing number of Turks, especially those of the younger generation, see themselves as European and Muslim at the same time. So forth so, some Iranians argue that the major transformations of the Iranian revolution occurred not in 1978-79 but with the coming of age of a new generation of Iranians who were not even born at the time of the revolution. These transformations include a greater sense of autonomy for both women and men and the emergence of a public sphere in which politics and religion are subtly intertwined, and not always in ways by Iran's formal religious anticipated leaders. Similarly, there are lots of developments in the life of Muslims living in France, Turkey, Iran, Indonesia, and elsewhere that suggest that they are living through an era of profound social transformation for the Muslim majority world. Mass education and mass communication in the modern world facilitate an awareness of the new and unconventional. He further said that mass education and mass communications are

contemporary all important in religions. However, the full effects of mass education, especially higher education, only began to be felt in much of the Muslim world since mid-century and in many countries considerably later. including after country country Morocco, Egypt, Turkey, and Indonesia opportunities educational dramatically expanded at all levels. Even where adult illiteracy rates in the general populace remains high, as in rural Egypt and Morocco, there is now a critical mass of educated people able to read, think for themselves, and react to religious and political authorities rather than just listen to them. Women's access to education still lags behind that of men, although the gap is rapidly closing in many countries. education and Both mass particularly the communications. proliferation of media and the means by which people communicate, have had a profound effect on how people think about religion and politics throughout the Muslim world.

In his presidential remarks, Prof Dr. Mohammad Nejatullah Siddiqui, a noted economist, scholar and Shah Faisal Award winner, said that the condition of Indian Muslims, especially in the field of education and financial system is not good. Indian Muslims are less privileged than other country fellows. We need to solve point by point.



Hamdard International Unani Medicine Conference 2013 was held on 25th February 2013 and was presided over by Hamdard University Chancellor Sadia Rashid.

The conference was organised by the faculty of Eastern Medicine, Hamdard University on the topic of Unani Medicine: Education and Research Issues, Prospects and Challenges.

Chief Guest and former Sindh governor Lt. Gen (Retd.) Moinuddin Haider said that

the people who were living in far flung areas mostly depended on system of traditional medicine or homeopathic for their treatment and if they did not get the same they would go to other spiritual healers. Tibb-i-Unani no doubt was an effective system of medicine and Shaheed Hakim Mohammed Saeed and Hamdard University played a great role in promotion of tibb and got it recognised by World Organisation. Health But without improving its teaching, training and state patronage it could not be able to meet the modern requirements, he added. He said that the German doctor, Prof Dr Stefan Reichmuth just read his research paper on Melancholia, a disease that filled the human brain with Sodawi matter, resulting emotions highly instable imaginations and might lead to madness. The people who made suicide bombings should be treated by Unani medicine to get the country out of the menace of terrorism and suicide bombing, he added. Physicians of unani and other traditional systems of medicine are being paid near about Rs. 65,000 per month in India, because the Indian government has these recognised systems. But Pakistan. the traditional system of facing great problems. medicine is

In his keynote, Prof Hakim Syed Zillur Rahman, President, Ibn Sina Academy of Mediaeval Medicine and Sciences. Aligarh, India said that Tibb-e-Unani was not a dead system of medicine but still existing, being a natural system of cure. said thousands of people He subcontinent of Indo-Pak and Bangladesh and in many other countries are getting cure from this time honoured system of treatment, because it based on clinical experiments and scientific knowledge. "Today the whole world is in search of an alternative system of cure and people are taking interest in herbal and traditional medicine," he added. Being herbal the Tibb-e-Unani has full capacity to become an effective alternative medicine. He said

Tibb-e-Unani has holistic approach in treatment of diseases as it treats not a disease but the patient keeping in view his her whole body and personality. The major setback in Allopathic system of medicine is that it does not give emphasis on the relation of brain and body though it takes notice of effect of environment on health and disease but does not give importance to the connection of mind and health.

Another keynote lecture was delivered by Prof. Dr. Stefan Reichmuth, Director, Institute for Oriental and Islamic Studies, Ruhr-University Bochum Universitätsstr, Germany.

Speakers of a moot stressed better education and training facilities to promote Unani medicine.

Concluding Session of the third Hamdard International Unani Medicine Conference 2013 – A report

Speakers including Hakim Abdul Hannan, Vice Chancellor, at the concluding session of third Hamdard International Unani Medicine Conference on "Unani Medicine: Education and Research Issues. Prospects and Challenges", said that integration of different systems medicine was necessary to resolve the problem of public healthcare, particularly in rural areas.

The concluding session was held on 27.2.2013 and presided over by Mrs. Sadia Rashid. Chancellor. Hamdard University at Bait al-Hikmah Auditorium. Madinat al-Hikmah, Karachi. Chief guest and president of Ibn Sina Institute of Tibb, South Africa, Rashid Bheka said that the problem of healthcare throughout the world could not be resolved without integration of all systems of medicine, including Tibb-e-Unani, as no system of medicine was complete and had the capacity to resolve the healthcare problem alone.

He said it was his own experience that no single system of medicine could cure all patients. Because, when his daughter seriously fell ill and the doctors failed to cure her and even to diagnose her disease, he then took the facility of traditional medicine and his daughter got cured by the treatment of *Tibb-e-Unani* and this made him to believe in this system of medicine.

This particular event had changed his mind and his journey towards *Tibb-e-Unani* had started, he said, adding that he came in Pakistan in 1994 and met with Hakim Mohammad Said and he and Hamdard Pakistan had guided and cooperated with him, that's why he succeeded in establishing an institute of tibb in South Africa. 'I believe, there would be a big contribution of *Tibb-e-Unani* in resolving the public health care issue in future', he concluded.

Dr. Usman Ghani Khan took an account of conference's proceedings and said that the conference as a whole was successful. However, the education and training of Tibb-i-Unani was needed to be more emphasized on, he added.

Dr. Aftab Saeed, Director, Hamdard Research Institute of Unani Medicine, Hamdard University submitted the following recommendations in the session, based on the speeches, observations and papers presented in the 3 day conference: Unani/Herbal traditional medicines provide low-cost remedies for rural health care; therefore, the traditional medicine should be explored, encouraged and developed into primary health care programs.

Government and nongovernmental organizations should help to create and support education and use of traditional medicines on priority basis. Government of Pakistan should promote and support research and development at the

University level in order to introduce regimental therapies at large and to modernize techniques for producing effective natural health care products.

The Faculty of Eastern Medicine, Hamdard University be declared as WHO Centre for Collaborative Research on Traditional Medicine and that Shifaul Mulk Memorial Hospital, working under the Faculty of Eastern Medicine, Hamdard University as the Centre of Excellence for Primary Health Care.

The National workshops on traditional medicine practices and utilization should be further channelized so as to facilitate and promote innovative research strategies for traditional medicine through the coordination of interdisciplinary and collaborative research.

The recommendations made the International Association of Unani Medicine IAUM, Faculty of Eastern University, Medicine FEM Hamdard Pakistan Association for Eastern Medicine PAEM Herbal and Manufacturing Association of Pakistan, National Institute Health NIH Islamabad strengthening the practice of Traditional, Complementary or Alternative Medicines should be given priority implementation, harmonization integration of traditional medicine into health care delivery systems.

Certificates were given away to the participants of the conference and cash prize to Saima Ghayas on winning the poster competition.

Hakim Rahat Nasim Sohdervi, Senior Vice President, Pakistan Association for Eastern Medicine offered vote of thanks and Dr. Maham Munir Ahmed, Vice President, Hamdard Foundation Pakistan, gave concluding remarks.

NEW BOOK

Science and Religion in Mamluk Egypt: Ibn al-Nafis, Pulmonary Transit and Bodily Resurrection (Culture and Civilization in the Middle East) by Nahyan Fancy

The discovery of the pulmonary transit of blood was a ground-breaking discovery in the history of the life sciences, and a prerequisite for William Harvey's fully developed theory of blood circulation three centuries later. This book is the first attempt at understanding Ibn al-Nafis's anatomical discovery from within the medical and theological works of this thirteenth century physician-jurist, and his broader social, religious and intellectual contexts.

Although Ibn al-Nafis did not posit a theory of blood circulation, he nevertheless challenged the reigning Galenic Avicennian physiological theories, and the then prevailing anatomical understandings of the heart. Far from being a happy guess, Ibn al-Nafis's anatomical result is rooted in an extensive re-evaluation of the reigning medical theories. Moreover, this book shows that Ibn al-Nafis's reevaluation is itself a result his

engagement with post-Avicennian debates on the relationship between reason and revelation, and the rationality of traditionalist beliefs, such as bodily resurrection.

Breaking new ground by showing how medicine, philosophy and theology were intertwined in the intellectual fabric of premodern Islamic societies, *Science and Religion in Mamluk Egypt* will be of interest to students and scholars of the History of Science, the History of Medicine and Islamic Studies.

Research Associate for the project, Arabic Commentaries on the Hippocratic Aphorisms, The University of Manchester-School of Arts, Languages and Cultures

The Hippocratic Aphorisms have exerted a singular influence over generations of physicians both in the East and in the West. Galen (d. c. 216) produced an extensive commentary on this text, as did other medical authors writing in Greek, Latin, Arabic, and Hebrew. The Arabic tradition is particularly rich, with more than a dozen commentaries extant in over a hundred manuscripts. The present project breaks new ground by conducting an indepth study of this tradition through a methodology: innovative highly approaches the available evidence as a corpus, to be constituted electronically, and to be analysed in an interdisciplinary way. Professor Peter E Pormann has European €1.5m from the obtained Research Council, and he will be the project lead.

There are two full-time posts which are both available from 1 October 2013 for three years. They will be based in the main University campus (Samuel Alexander Building) although some research will require travel to libraries and
